

RULES AND REGULATIONS

- 1. Participants must reside in one of these jurisdictions: Town of South Bruce Peninsula, Municipality of Northern Bruce Peninsula, Township of Georgian Bluffs or City of Owen Sound.
- 2. Participants must be currently enrolled in a secondary school in one of these jurisdictions.
- 3. Participants agree to seek their own business sponsor, where possible. This sponsor must conduct business in the Town of South Bruce Peninsula, Municipality of Northern Bruce Peninsula or the Township of Georgian Bluffs.
- 4. Participants agree to submit sponsorship fee (\$50.00) and registration packages to the pageant organizer no later than Monday, October 26, 2015.
- 5. Pageant winners must be available during Prediction Morning, Tuesday, February 2, 2016 as well as for the events associated with the Wiarton Willie Festival. Exceptions will be made to accommodate exams and studying time.
- 6. Participants and/or relatives of participants shall not approach the pageant judges with the intent to influence or harass.
- 7. Participants must conduct themselves in a professional manner.
- 8. Participants shall provide their own wardrobe for the Willie Fun Day, preliminary judging and pageant. Participants are welcome to seek sponsor assistance with their wardrobe and/or accessories. This is certainly not a requirement of your sponsor.
- 9. Participants will take part in the Willie Fun Day on Sunday, November 1, 2015 from 10:00 a.m. to 3:00 p.m. home base is Dockside Willie's, 402 William Street, Wiarton. Relaxed, comfortable attire is appropriate.
- 9. Preliminary judging will take place on Sunday, January 24, 2016 beginning at 1:00 p.m. at Dockside Willie's. This will be an informal opportunity for the participants and judges to gather socially in a meet and greet setting. Business casual attire is acceptable for the preliminary judging session. The Wiarton Echo will be on hand to photograph the contestants.
- 10. Participants are required, on pageant day, Friday, January 29, 2016, to arrive at the Wiarton Meeting Place, 575 Edward Street, no less than forty-five (45) minutes prior to the event. The event will commence at 7:00 p.m. Semi formal dress is appropriate for the pageant event.
- 11. Wardrobe, hair, make-up and such shall be the responsibility of the participant.
- 12. Only the first fifteen (15) participant registrations received will be accepted for the pageant.

GENERAL PAGEANT INFORMATION

The Queen of the Festival pageant was reborn for the Wiarton Willie Festival in 2010 after an absence of some eighteen years. 2016 will be the 60th Anniversary of the Wiarton Willie Festival. The Festival founder is Mac McKenzie.

The pageant is very fortunate to have lead sponsor, Nicol Insurance, on board. A \$1,000.00 bursary will be awarded to the 2016 Queen of the Festival, a \$300.00 bursary to the 1st Runner-up (Festival Princess) and a \$200.00 bursary to the 2nd runner-up (Festival Princess).

On Sunday, November 1, 2015, all contestants will assemble at 10:00 a.m. at Dockside Willie's for the Willie Fun Day. Please dress casually and comfortably. The girls will be treated to a variety of activities during the course of the day—spending time at local businesses plus discussing topics such as clothing, lifestyle, nutrition, health and wellness, aesthetics as well as sessions about financial planning, motivation and the environmental heritage. Lunch will be served by our kind hosts, Tanya and Greg Norton, at Dockside Willie's. This is intended as a fun, social, interactive and hopefully, educational day for the pageant contestants and judges.

On Sunday, January 24, 2016, preliminary judging will take place at Dockside Willie's. Dress is business casual. The afternoon will consist of a meet and greet time and talk involving the contestants and judges as well as a little one on one time so that the judges can get to know each girl a little more.

On Friday, January 29, 2016, contestants will gather at the Wiarton Meeting Place at 6:15 p.m. at which time, each contestant will be given a question that she will be required to answer in front of the audience and judges. The contestant will have 30-45 minutes before the event to "wrap her head" around her answer to the question. She is permitted to use her notes when delivering the answer in front of the audience. The pageant will commence at 7:00 p.m.

As the event begins, the contestants will be introduced individually and then be seated in the front row. A sash, printed with the name of your business sponsor, will be worn at the pageant. Please keep your sash as a token of your participation.

It is expected that the Queen of the Festival and Princesses will appear at as many Festival events as possible. The pageant organizer will be pleased to escort the Queen, Princesses and Miss Congeniality to various festival activities. Most importantly, it is imperative that the Queen of the Festival, Princesses and Miss Congeniality are present at Prediction Morning, Tuesday, February 2, 2016 in Bluewater Park.
