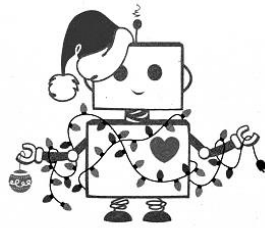


# 2015 WIARTON CHRISTMAS PARADE ENTRY FORM

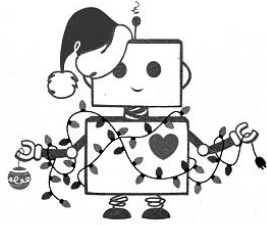
